PSYCHIATRIST

BASIC FUNCTION:

Under the direction of the All-4-Youth Director of Clinical Services, evaluate and diagnose youth for medical and psychiatric needs and implement treatment plans for mental, emotional, and behavioral health disorders in collaboration with assigned treatment team; treat youth with psychotherapeutic methods, prescribe psychotropic medications, and monitor, and evaluate treatment results and progress; maintain records by documenting symptoms, medications, treatment, and progress.

REPRESENTATIVE DUTIES:

ESSENTIAL DUTIES:

- Analyze data and results of assessments to diagnose patients.
- Assess and screen patients by conducting psychiatric evaluations, including interviews, medical histories, physical exams, observations, and psychological testing.
- Assist patients by evaluating medical and psychosocial conditions.
- Collaborate with treating clinician on diagnosis and treatment.
- Collaborate with treatment team from a lens that supports an integrated approach, blending a
 medical model within the educational system for optimal mental health service delivery while
 reducing barriers and limitations to care for youth served.
- Complete all necessary clinical documentation in an accurate and timely manner, entering into designated electronic health record system(s).
- Complete audits, including medication monitoring, chart reviews, summaries of findings, and corrections as needed for quality improvement.
- Develop a treatment plan, measure progress against the plan, and make adjustments as needed.
- Develop and implement treatment plans, including prescription of psychotropic medications.
- Develop treatment plans by determining the nature and extent of cognitive, emotional, developmental, social, and behavioral disorders and establishing treatment goals and methodologies.
- Enhance department and organization reputation by accepting ownership for accomplishing new and different requests and exploring opportunities to add value to job accomplishments.
- Ensure quality and safe service delivery for youth (patients) and staff by enforcing policies, procedures, standards, rules, and legal regulations; participating in utilization reviews; and remaining available for emergency consultations.
- Ensure that Treatment Authorization Requests (TAR) and Judicial Council forms (JV 220 and JV 223) are current prior to prescribing.
- Evaluate youth by interviewing youth, family, and other persons; conduct physical examinations; observe behaviors; review medical history and related documents; select, administer, and interpret psychological tests; and order laboratory tests and evaluate results.
- Follow policies and procedures for incident reporting, child abuse and mandated reporter obligations, safety planning, root cause analysis and external reporting.
- Implement an integrated approach that blends a medical model within the educational system for optimal mental health service delivery to reduce barriers and increase access to care.

- Improve staff competence by providing training and discussions regarding the interrelationship between psychosocial and physiological problems, psychotropic medications, crisis intervention, and related issues.
- Maintain historical records by documenting symptoms, medications, and treatment events and writing summaries.
- Maintain interdisciplinary treatment by reviewing and adjusting treatment plans and assessing
 progress, and coordinating, consulting, and collaborating with primary care physicians, mental
 health therapists/clinicians, nurses, other health care providers, and school
 psychologists/school counselors and other disciplinary team members around treatment and
 care.
- Monitor and evaluate treatment results.
- Monitor patients to determine efficacy and potential side effects of medications.
- Prescribe and administer medications according to diagnosis.
- Provide both in-person and telehealth services.
- Provide crisis intervention as needed.
- Provide timely prescriptions as needed.
- Treat youth by utilizing psychotherapeutic methods and medications; discuss progress toward goals with youth; provide instructions; monitor effect of medications; and supervise staff (as applicable) provision of services.
- Update job knowledge by participating in continuing medical educational opportunities, reading professional publications, maintaining personal networks, and participating in professional organizations.
- Attend and participate in a variety of assigned meetings, committees, conferences, in-services and/or special events.
- Comply with schedules, policies, regulations, procedures, orders, and directives of the County Superintendent.
- Exhibit professionally appropriate interpersonal skills including but not limited to tact, patience, flexibility and courtesy.
- Maintain a safe work environment.
- Operate a variety of office equipment, including but not limited to a computer and assigned software applications.
- Serve as a liaison between County Superintendent and administrators, personnel, outside organizations or the public concerning assigned area.
- Serve as a technical resource concerning assigned program, function or instructional area.
- Work collaboratively and maintain effective working relationships with others in the course of work in assigned area.

OTHER DUTIES:

- Drive a vehicle to conduct work, using own transportation.
- Perform related duties as assigned.
- Travel within Fresno County, statewide and/or nationwide.
